Concentration: Lyophilized

Formulation: Lyophilized, 10 mM Sodium Phosphate, 0.15 M Sodium Chloride, pH 7.2, 1 % (w/v) BSA, Protease/IgG free and 0.1% (v/v) Kathon CG

Reconstitution: Rehydrate with 0.55 ml of deionized water and let stand 30 minutes at room temperature to dissolve. Centrifuge to remove any particulates. Prepare fresh working dilution daily.

Storage Conditions: Store freeze-dried powder at 2-8 °C. Once rehydrated and in solution store at 2-8 °C.

Use By: 1 year from date of receipt. Store lyophilized material at 2-8 °C. For long term storage after reconstitution, dilute with 50% glycerol and store at -20 °C as a liquid.

Purity: > 90% based on SDS-PAGE small amounts of intact IgG may be present

Purification: Affinity purified using solid phase Human IgG

Country of Origin: Goat serum was obtained from healthy animals of US origin and under the care of a registered veterinarian.

PREPARATION & STORAGE

This product was Affinity purified using solid phase Human IgG. Store freeze-dried powder at 2-8 °C. Once rehydrated and in solution store at 2-8 °C.

APPLICATION NOTES

This conjugate is suitable for Western Blot, ELISA and immunohistochemistry. The optimal working dilution should be determined by the investigator. Suggested starting dilution(k): · 1:20 - 1:2,000 for most applications Based on IEP, this antibody reacts with: · heavy (γ) chains on human IgG · light chains on all human immunoglobulins.
